TO: Conway Local Eating Establishments

SUBJ: Easing of Zoning Restrictions

DATE: March 24, 2020

In an effort to assist local eating establishments during the State of Arkansas moratorium of on-premises dining and to provide additional support for the health and welfare of Conway citizens by providing alternative opportunities to purchase food and other items, I, Mayor Bart Castleberry, will be suspending certain zoning and ordinance restrictions on eating establishments to **allow eating establishments to sell food, ingredients, cleaning supplies, paper goods or sundries** inside the city limits under the following conditions:

1. No more than ten (10) persons inside the premises at any one-time including staff/employees;
2. All business owners are responsible for ensuring proper social distancing practices are followed;
3. All business owners are subject to any and all Centers for Disease Control (CDC), World Health Organization (WHO), Arkansas Department of Health, federal government and/or state government orders or directives;
4. These businesses will not need any other permits or permission to deliver items mentioned above for residential use or consumption;
5. This executive order is subject to all CDC, WHO, Arkansas Health Department, federal government and/or state government orders or directives which will control if a conflict arises; and
6. This will remain effect for a period of thirty (30) days or until further notified.

My office, city employees and officials are doing all we can to support and protect everyone in the city, including our businesses. I know how vital these businesses are to the prosperity and quality of life Conway has long enjoyed.

SUBJ: Easing of Zoning Restrictions
DATE: March 24, 2020

The hotels and motels of our community have been significantly impacted by the restrictions put in place during this COVID-19 pandemic. With this slow down these businesses have large inventories of cleaning supplies and other items that are building up. These items can be used by our citizens to help protect them against the risk of infection.

To provide alternative opportunities for citizens to have access to these necessary supplies, I, Mayor Bart Castleberry, will be **suspending certain zoning and ordinance restrictions on Conway's hotels and motels to allow them to sale cleaning supplies, paper goods or sundries** inside the city limits under the following conditions:

1. No more than ten (10) persons inside the premises at any one-time including staff/employees;
2. All business owners/managers are responsible for ensuring proper social distancing practices are followed;
3. All businesses are still subject to any and all Centers for Disease Control (CDC), World Health Organization (WHO), Arkansas Department of Health, federal government and/or state government orders or directives;
4. These businesses will not need any other permits or permission to deliver items mentioned above for residential use;
5. This executive order is subject to all CDC, WHO, Arkansas Health Department, federal government and/or state government orders or directives which will control if a conflict arises; and
6. This will remain effect for a period of thirty (30) days or until further notified.
